

# Ashlar House 100 club Membership application



## **Purpose:**

The purpose of the Ashlar House 100 Club is to raise funds to help reduce the overall debt of Ashlar House and ensure its long-term sustainability and continued service to our Masonic community. Members' contributions (including your own) received into the recipient's (Ashlar House 100 Club) bank account will be used to pay out winning prize money (30% for monthly draws and 60% for Super Draws). The remaining funds (70% for monthly draws and 40% for Super Draws) will be used to reduce the debt owed by Ashlar House. These funds will not be used for renovation or any other purposes by the Hall Company.

## **Cost and Duration:**

Membership requires a minimum contribution of £2.00 per month for a duration of 12 months.

## **Rules:**

1. The contribution of £2.00 per month (i.e., the minimum per draw) must be made on the 1st of each month via bank standing order. Failure to maintain monthly payments will result in the forfeiture of all winnings for that monthly draw for all allocated membership numbers.
2. There is no maximum number of entries a member can buy. Each additional £2.00 entry purchased is bound by the same 12-month stipulation.
3. Draws will be made on the 28th of each month.
4. The monthly prize money will be 30% of the monthly membership contributions received that month. Twice a year, there will be a Super Draw (in June and December), where the prize money will be 60% of that month's membership contributions.
5. Monthly prize money allocations will be as follows: 1st prize - 15%, 2nd prize - 10%, 3rd prize - 5%. Super Draw prize allocations will be as follows: 1st prize - 25%, 2nd prize - 20%, 3rd prize - 15%.
6. The Ashlar House 100 Club is a small private lottery open to all members aged 18 or over from Masonic lodges and other degrees which meet at Ashlar House in Bury St Edmunds.
7. By subscribing, members agree to make a monthly standing order for the correct amount each month.
8. A one-month notice period must be given when cancelling your membership.
9. Member numbers will only be valid for draws if their subscriptions are up to date.
10. The draw will be made by the registered Ashlar House 100 Club promoter.
11. Winners will be notified by the email they have provided, and prize money will be paid directly to each winner's bank account by bank transfer within 7 days of the draw.
12. The names and numbers of each monthly prize winner will be distributed by the Secretaries to all members and will be displayed at Ashlar House.
13. The Ashlar House 100 Club will be publicised by the promoter and 3 Lodge Officers. In the case of any dispute, the decision of these members is final.
14. Unless otherwise advised, a member will be deemed to have left the Ashlar House 100 Club if their subscription or renewal contribution remains unpaid for one calendar month after the date of the previous draw.
